#### AMAZING LIFE FOUNDATION TERMS OF USE

These Terms and Conditions of Use (the "Terms of Use") apply to the websites, mobile applications, and software owned or operated by Amazing Life Foundation, Inc. Any claim under these Terms of Use must be brought within one (1) year after the cause of action arises, or such claim or cause of action is barred, unless a different limitation period is mandated by Texas law. No recovery may be sought or received for damages other than out-of-pocket expenses, except that the prevailing party will be entitled to costs and attorneys' fees as permitted under Texas law. In the event of any controversy or dispute between ALF and you arising out of or in connection with your use of the ALF Sites, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable Texas law.

#### **Void Where Prohibited**
